ORDER

On July 14, 2014, His Excellency Benigno Simeon Cojuangco Aquino III signed *Proclamation No. 826* declaring July 29, 2014 (Tuesday) as a regular holiday throughout the country in observance of *Eid'l Fitr* or the end of the holy month of Ramadan for Muslims.

Relative thereto, the scheduled hearing for the above-captioned case on July 29, 2014 is hereby reset to **August 12, 2014 (Tuesday)** at nine o'clock in the morning (9:00 A.M.) at the **Solidarity Hall, ORMECO Compound, Barangay Sta. Isabel, Calapan City, Oriental Mindoro.**

Oriental Mindoro Electric Cooperative, Incorporated (ORMECO) and Emerging Power, Incorporated (EPI) are hereby directed anew to cause the publication of the attached Notice of Public Hearing, at their own expense, twice (2x) for two (2) successive weeks in two (2) newspapers of general circulation in the Philippines, with the date of the last publication to be made not later than ten (10) days before the

date of the scheduled initial hearing. They are also directed to inform the customers within ORMECO's franchise area, by any other means available and appropriate, of the filing of the instant application, their reasons therefor, and of the scheduled hearing thereon.


