KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT made on the ____ day of _____ 2012 between the ENERGY REGULATORY COMMISSION (ERC) of the Philippines (hereinafter called "THE ENTITY", a government agency duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office address at 16th Floor, Pacific Center Bldg., San Miguel Avenue, Pasig City, represented by its Chairperson and Chief Executive Officer, ATTY. ZENAIDA G. CRUZ-DUCUT, on the one part and the SANDZ SOLUTIONS PHILIPPINES, INC., a corporation duly organized and existing under and by virtue of the laws of the Philippines, with principal address at 6/F CYA Building, 110 Rada Street, Legaspi Village, Makati City, Metro Manila, hereinafter referred to as "THE SUPPLIER", represented by its duly authorized representative, MS. TRIXIE JANE G. MOLINOS, of the other part:

WHEREAS, THE ENTITY invited Bids for certain goods and ancillary services, viz., Two (2) Units of Disaster Recovery and Backup Equipment Deduplication Storage and has accepted a Bid by THE SUPPLIER for the supply of those goods and services in the sum of ONE MILLION SIX HUNDRED EIGHTY EIGHT THOUSAND AND EIGHT HUNDRED PESOS (PhP1,688,800.00) [hereinafter called "the Contract Price"].

 - (f) the Client's Notification of Award (Annex "F").

In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract. Provided that the Supplier shall provide training for the use of the equipment subject of this contract.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
